PROSPECTUS FOR THE SESSION 2023-24

1. THE UNIVERSITY.

The Odisha University of Agriculture and Technology (OUAT) was established in the year 1962 in accordance with the provision of the Orissa Act 20 of 1961 and is a State Agriculture University. It has the triple function of teaching, research and extension.

The University offers education at the undergraduate and post graduate level in Agriculture, Veterinary Science & Animal Husbandry, Agricultural Engineering & Technology, Fishery Science, Community science, Forestry, Horticulture and Basic Sciences. Three Career Oriented Master's Programmes in Computer Science and Application, Bioinformatics and Agri-Business Management are offered by the Centre for Post Graduate Studies as self-financing courses. Research and Extension programme are carried out at the Regional Research and Technology Transfer Station (RRTTS) and/or sub stations/ Krishi Vigyan Kendra (KVK) located in different parts of Odisha.

2. THE COLLEGE OF BASIC SCIENCE & HUMANITIES.

The College of Basic Science & Humanities was established in 1964 as a constituent College of OUAT, Bhubaneswar.

The college offers teaching at **Undergraduate (UG) and Postgraduate (PG) level**. At the UG level, facilities for Honours courses are available in 8 subjects namely, Physics, Chemistry, Mathematics, Botany, Zoology, Biotechnology, Microbiology and Computer Science. At the Post Graduate level, the college offers Master's degree programme in Physics, Chemistry, Botany, Zoology, Mathematics, Microbiology and Biotechnology. Further, it offers the Ph.D. programme in Physics, Chemistry, Mathematics, Botany, Zoology & Microbiology. The B. Sc. and M. Sc. Courses, offered are under the semester system. The Ph. D. Programme has Pre-Ph. D. Coursework of six months duration as per UGC regulation.

In addition to the above, the college offers supporting courses to the students of other constituent colleges of OUAT.

5. PROCEDURE FOR GETTING PROSPECTUS AND APPLYING ONLINE.

5.1 Prospectus Download:

The prospectus may be downloaded from the university website at ouat.ac.in “Doctoral Prospectus 2023-24 (Science Subjects). The candidates are advised to read the prospectus carefully and act accordingly.

5.2 How to fill the Online Form:

i) Open the website, Login and open the online Application Form:

1. Open the website ouat.ac.in. Click the ACADEMIC → ADMISSION Tab in Menu Bar. Then click on “Student login for Online Application for Doctoral (Ph.D.) Course Programme in Basic Sciences – 2023 (College of Basic Science and Humanities)”. You will reach the log in page

Or

2. Open the website <https://ouat-lokaseba-odisha.in/> You will reach the log in page
3. Log in by providing your e-mail id, mobile number, OTP sent to the mobile Number/e-mail and the Captcha code.
4. After successful login, the “Apply Section” page will appear which contains the Apply buttons.
5. Click the “Doctoral Programme - 2023 (Science Subjects)”.
6. The “Form for admission into Doctoral Programme - 2023 (Science Subjects)” will appear with instructions to fill the form which you must read.
7. Now you will fill this online application form without leaving any * marked mandatory field

ii) Select Programme and Institute Type: First select Department from dropdown box. Then mention whether you have passed/appeared the qualifying examination from University/Institution recognized by UGC.

Fill Applicant Details and upload Photograph and Signature: Fill all the fields under Applicant Details. Please upload your recent passport size colour photograph (200px × 150 px; maximum file size 200 kb) and full signature (100px × 150 px; maximum file size 200kb) in jpg/jpeg format.

iii) Fill the Permanent and Present Address under the section Address Information: Fill/select address particulars.

iv) Fill Academic Profile: Under the section Academic Profile of the Applicant, Fill/Select carefully, Post Graduation degree particulars. Be particularly careful while filling the Total mark and Marks Scored. If grades awarded instead of marks, the candidate must enter correct total grade, grade secured and percentage of marks following the university conversion rule.

If your post graduation result is not declared yet, still you can apply leaving the mark box empty within the last date of application for admission i.e., 24.11.2023 (Midnight). Otherwise your candidature will be rejected. You can enter the 3rd graduation marks/grade till 29.11.2023.

v) The candidate will submit a self declaration that he/she will produce all relevant documents in original at the time of admission, failing which admission will be denied.

vi) Self Declaration: Candidate must click on self-declaration. By clicking this, the candidate is accepting that all the information he/she has submitted are true, and he/she will be responsible for any false or misleading information. Any false information submitted may make the application liable for rejection.

vii) Submit Application form: Before submitting, the candidate can have a preview of the application and make correction if required. After submission of online application form, an application number will be generated and sent to YOUR mobile number & e-mail.

viii) Make Payment: The **application fee of Rs. 1,500/-** (Rupees one thousand five hundred only) has to be paid besides bank charges as specified by the Bank depending upon the mode of payment selected through online payment gateway using internet Banking/Debit Card/Credit Card of any Bank.

Once you pay the fee, you will receive a message confirming the acceptance of application in mobile phone and e-mail. Fees, once paid, cannot be refunded under any circumstances. Without payment of application fee, the Application Form will be rejected.

If the online payment is failed, then the candidate must make the payment again. If the money has been deducted from the account in the previous attempt (in case of the failed transaction), that will be reverted to the source account within 8 working days.

ix) For subsequent Access: Registered mobile number and e-mail are always required to access your profile each time with OTP sent to mobile number and e-mail. You are advised to use your application number for subsequent access. You will need to access your profile for Editing the on line Application Form, to Download Admit card and to Download the Intimation cum Rank card.

5.3 Editing the online Application Form: Application is editable till the last date of submission of application i.e. 24.11.2023. However, you can enter the final CGPA/ marks of the qualifying examination till 29.11.2023. For each instance of editing you have to access your profile by the method mentioned above.

5.4 Download of Admit Card: The admit card will be available from 05.12.2023. The Admit Card can be downloaded from the website (ouat.ac.in or <https://ouat-lokaseba-odisha.in/>) by accessing download hyperlink using application No. and date of birth. **The admit card will never be sent through post.** The candidate must bring the Admit card with **any of the following original** identity proof to the Entrance Examination Centre for verification.

5.5. Intimation-cum-Rank Card Download: When Intimation is ready, an SMS will be sent to your mobile. You will download it by accessing your profile by the method mentioned above. **Intimation letter will never be sent through post. It will be available for download on 20.12.2023**

5.6. Important Information.

1. Candidates must submit the application with application Fee within the last date of submission of application form i.e. 24.11.2023. Application without fee will not be considered for entrance examination and admission. The application will be editable till last date of submission of application.
2. After successful payment, the candidate should take printout of computer generated filled in Application Form with payment detail for his/her personal record
3. You must have your own personal e-mail ID and Mobile Number with validity till the completion of the Admission process, all important information on application number, various alerts and download of Admit card, rank and Intimation-cum-rank card and other necessary information will be sent to you only by SMS and email. Under no circumstances, you should share the password of your e-mail ID and Mobile/Cell Number with any other person. If you do not have a valid e-Mail ID, please create a new e-Mail ID. You will be provided with a login ID and password to login on to the website ouat.ac.in/<https://ouat-lokaseba-odisha.in/> for all future references. Your Admit Card, rank and intimation-cum-rank card can be accessed online by using the links provided on the website ouat.ac.in/<https://ouat-lokaseba-odisha.in/> from the download hyperlink.
No separate physical communication would be sent.
4. A candidate is required to **submit one application** for which he/she wishes to be considered for admission.
5. The data obtained from the candidate while applying online will be used for the purpose of generating Admit Card for Entrance Examination. Hence the applicants are advised to submit data accurately as required while applying online.
6. Hard copy of application must not be sent to OUAT.
7. The University will not be liable to refund the application fees deposited by the candidate.

6. SELECTION OF CANDIDATES

- 6.1 There shall be an Admission Board with the Director, College of Basic Science & Humanities as Chairman and one faculty member from each department as member.
- 6.2 **Entrance Examination:** The candidates have to appear in the entrance examination in the College of Basic Science and Humanities, O.U.A.T on **12.12.2023 at 11.00am to 1.00pm**. The examination will be of 2 hours duration with 100 multiple choice questions covering the course taught at Master's Level. **For every correctly answered question 2 marks will be awarded. For every un-attempted or wrongly answered question, 0 mark will be awarded.** All candidates fulfilling the minimum eligibility will download admit card and will appear in the entrance examination. No candidate shall be allowed to enter the examination hall without admit card and identity proof as mentioned in the section 5.4.
- 6.3 The selection for admission into different Doctoral Programme will be based on merit of the candidates. There will be separate Merit lists for each subject of Doctoral Programmes.
- 6.4 **Merit list of the candidates shall be drawn up on the basis of the total marks, scored in Entrance Examination. In case of a tie of entrance marks, it will be resolved by taking into account the percentage of marks secured in qualifying examination. If a candidate does not submit the qualifying examination marks, then the candidate will be placed at the lowest rank in the group of candidates having same entrance score.**

7. ADMISSION PROCEDURE

- 7.1 Admission into Ph.D. course will be conducted by the Admission Board.
- 7.2 The merit list of the candidates for admission will be available in the OUAT website ouat.ac.in and <http://ouat-lokaseba-odisha.in>. The candidate can download the intimation-cum-Rank Card from the above website. Intimation for admission will not be sent by post.

- 7.3 In the event of any change in the scheduled date of admission the same will be notified in the Notice Boards of the University and the College as well as in the website for information of the candidates. This will also be sent to the mobile as SMS and to the email of the candidate.
- 7.4 A candidate who fails to appear for admission on the scheduled date, time and place will automatically and irrevocably forfeit his/her claim for admission.
- 7.5 The candidates coming for admission should bring with them all the original certificates and mark sheets for verification at the time of admission. They have to submit their college leaving certificate and conduct certificate (if the same is not mentioned in the CLC) in original from the head of the institution last attended.
- 7.6 Candidates are advised to enter correct final CGPA/marks in the application form under academic profile. If a candidate submits CGPA, then the percentage of marks must be as per the conversion rule of grade to percentage adopted by the university. In case of tie, any wrong entry of final CGPA/marks, detected at the time of counseling and admission, then the candidate will be placed at the lowest rank in the group of candidates having same entrance score.
- 7.7 Candidates who passed their Masters degree from any University other than OUAT will have to submit their Migration certificate within 3 months, failing which they will not be allowed to appear in pre Ph. D Coursework examination.
- 7.8 All candidates selected for admission to Ph.D. course programme shall submit the Medical fitness certificate in prescribed form at the time of Admission.
- 7.9 In case the candidate for admission is found to have indulged in ragging in the past or if it is noticed that (s) he has indulged in ragging, admission will be refused or (s) he shall be expelled from the college and University.
- 7.10 The original documents like CLC, Migration, Conduct, submitted at the time of admission as required will not be returned to the candidates even temporarily under any circumstance.
- 7.11 All the admitted candidates need to submit an affidavit, as per the UGC guideline on non indulgence in ragging activities, to the Director, CBS&H within 15 days from the date of admission.

8. ACADEMIC SYSTEM

Duration of Course

8.1 A Ph. D course programme is a full-time study of three years which includes course work of six months duration and research work for rest of the period. The residential period is maximum 6 years (5+1year allowable extension) from the date of the synopsis presentation (to be held within one month of declaration of Pre-Ph.D. course work examination results). A candidate who successfully completes the course work will only be allowed to continue research for Ph.D. in the concerned subject.

The semester will have about 95 to 105 working days out of which teaching programme shall be at least 95 net instruction days (NIDs) excluding examination days.

8.1.1 Course Programme, Instruction and Evaluation.

8.1.2 The instruction is offered in English under course credit system. Each course is divided into distinct course units of courses. Each student admitted into a course programme shall take course as per the plan of course programme.

8.1.3 The course programme and examination will be regulated by the Semester regulations for Master's & Doctoral Programme of OUAT.

8.1.4 A student is required to have a minimum of 85% attendance in course work failing which he /she shall not be allowed to appear at the Pre-Ph.D. course work examination and will be detained in that semester, subject to regulation for condonation up to 15% by the Director of the College. The academic regulation may please be referred to.

9 HOSTEL AND MEDICAL FACILITIES.

9.1 Hostel accommodation may be provided to Ph. D students on merit basis subject to availability of seats. After admission, the students shall apply to the Dean, Students' Welfare (DSW) through the concerned Dean / Director of the College for their stay in a hostel.

9.2 The University runs a Dispensary manned by experienced doctors and it provides treatment to students of the University.

10 STUDENT ACTIVITIES.

10.1 **Students' union:** The students union comprising of student representatives is formed every year in the college to organize cultural/ athletic / sport activities. The students are also allowed to participate in various inter college and inter university competitions at state and national level to show their performances in extracurricular activities.

10.2 **Students' welfare:** The Dean of students Welfare looks after the extra curricular activities of the students. The university Employment information and Guidance Bureau acts as a useful channel of communication between the students and employment organizations.

11 STUDENTS DISCIPLINE.

A student shall abide by the disciplinary rules and Regulations of the college and the University and shall not involve himself / herself in any objectionable conduct such as violation of discipline, disobedience of instructions of authorities, immoral conduct or disorderly behaviour including ragging. In case a student is found to be involved in any of the above undesirable activities, he/she shall be liable for expulsion from the College if the offence is grave. The expulsion from the College shall be ordered by the Director College of Basic Science and Humanities with the concurrence of the Vice Chancellor.
