Guest faculties will be engaged in different subjects in the College of Agricultural Engineering and Technology, Bhubaneswar through walk-in interview to be conducted in the Office of undersigned on 9th July, 2024 at 10.00 AM.

Remuneration: Rs. 1000/- per class for both UG and PG subjects subject to a maximum of Rs. 40,000/- per month, or as may be revised/ notified by the University.

3	Irrigation and Drainage Engineering (IDE)	1	Master's Degree in the subject Irrigation and Drainage Engineering/ Water Resources Engineering/ Water Resources Development and Management/Water Management from a recognized University with minimum of 55% marks or equivalent of CGPA 5.5 in 10 point scale with good academic record.
4	Renewable Energy Engineering (REE)	1	Master's Degree in the subject Renewable Energy Engineering from a recognized University with minimum of 55% marks or equivalent of CGPA 5.5 in 10 point scale with good academic record.
5	Agricultural Structures	1	Master's Degree in the subject Agricultural Structures/ Agricultural Structures and Process Engineering/ Soil and Water Conservation Engineering or related subjects from a recognized University with minimum of 55% marks or equivalent of CGPA 5.5 in 10 point scale with good academic record.

In the event, suitable candidates are not available as per the eligibility criteria mentioned above, candidates having Master's Degree in relevant/ allied subject may also be considered.

Desirable Qualification:

- 1. Qualified NET conducted by ICAR/ UGC/ CSIR.
- 2. Ph.D. in relevant subjects.

The candidates will also be given due weightage for publication in reputed journals as well as for experience in related fields.

The engagement will be for the academic year 2024-25. The tenure of engagement may be terminated at any time before the end of academic year and also it may be further extended on satisfactory performance with due approval from competent authority. The incumbent shall not have any claim for regular appointment under OUAT.

The guest faculty may leave the assignment, on their own volition, by giving one-month notice and he/she will be relieved on acceptance of resignation, else he/she has to deposit one-month remuneration (maximum as pertinent) wherever applicable.

The candidate must bring all the original certificates from HSCE onwards and experience certificate (if any) with them, without which the candidate will not be allowed for the interview.

No objection certificate from the present employer, if any, is to be produced at the time of interview.

The selection panel will remain valid for one year. The undersigned reserves the right to increase or decrease the number of guest faculties to be engaged on the basis of need and approval of competent authority or to cancel the interview without assigning any reason.

Interested candidates will have to appear for a walk in interview on 9th July, 2024 at 10.00 a.m. in the Office of the Dean, CAET, OUAT, Bhubaneswar. The candidates can submit Biodata mentioning the contact details (including email-id and contact phone numbers) and achievements, list of publications, experience, etc. through email to swce@ouat.ac.in before 11 AM of 8th July, 2024.

No TA/DA will be given to the candidate for appearing the interview. The candidates desirous of attending the walk in interview must report at the venue latest by 10.00 AM on the date of interview.

The candidates will have to submit a DD of Rs. 500.00 in favour of Comptroller, OUAT, Bhubaneswar before appearing the interview.
