NOTIFICATION

Consequent upon receipt of clarification from the Govt. in DA & FE vide letter No. 26639/A&FE dated 06.12.2024, the notification issued vide No.9970/UAT dated 29.06.2024 towards the minimum eligibility for promotion of Teachers/ Scientists in different stages under Career Advancement Scheme (CAS) as per UGC Regulation-2018 is partially modified as follows.

1. The guideline mentioned at Annex-1, NB:1 may be read as below

“(i) Publications during the assessment period will be considered for eligibility, if a research paper is published at a date beyond the date of residency eligibility, the CAS should shift to that date.

However, so far as training is concerned, the relaxation (from the date of assessment and up to the date of notification) shall be applied, since going for training might have had administrative hurdles. The research papers/training qualifications once taken into account will not be counted again.

(ii) Popular articles and book chapters, suffixed by ISSN numbers and ISBN numbers, respectively will be considered.

(iii) The NAAS rating during the particular year of publication will be considered”

2. The guideline mentioned at API Score (from Academic level 10 to 11 & from Academic level 11 to 12) under “D” relating to SAR may be read as “Period of assessment: 4 years with Ph.D, 5 years with M.Phil/PG degree in professional courses 6 years without Ph.D / M.Phil/PG degree”

Other criteria mentioned in the notification No.9970/UAT dated 29.06.2024 remains unaltered.

The Teachers/ Scientists of this University, who are eligible for promotion in any stage under Career Advancement Scheme on or after **18.07.2018** may apply in the prescribed proforma alongwith required documents through their controlling officers to the Registrar, OUAT, Bhubaneswar, if not applied earlier for consideration.
