## **NOTIFICATION**

Sub: Equivalency of B.Sc. (Hons.) Community Science with B.Sc. (Home Science) -regarding

Pursuant to the subject cited, it is clarified that the Odisha University of Agriculture & Technology (OUAT) was established in the year 1962 in accordance with the provision of the Orissa University of Agriculture and Technology Act, 1965 and is a State Agriculture University. It is the second oldest Agriculture University of India and duly recognized by Indian Council of Agricultural Research (ICAR), New Delhi.

Odisha University of Agriculture & Technology (OUAT), Bhubaneswar, Odisha offers B.Sc. (Hons.) Community Science degree programme at its constituent college. As per recommendation of ICAR-Vth Deans' Committee, new course syllabus for different courses was implemented in OUAT from the academic session 2016-17 vide notification No.5285/UAT, dt. 21.02.2017. The ICAR introduced B.Sc. (Hons.) Community Science degree in place of B.Sc. (Home Science) degree during 2016. Accordingly, the College of Home Science was renamed as the College of Community Science as per the notification No.5252/UAT, dt. 20.02.2017 of the Registrar, OUAT. The ICAR has recommended vide D.O. No./ PPS/DDG (Edn)/2021, dt. 06.12.2021 to include the degree of B.Sc. (Hons.) Community Science as the eligibility criteria for higher studies, recruitment purpose and various competitive examinations conducted by the Union/ State Governments including banking sectors. Therefore, both the degrees are considered equivalent to each other as mentioned below.
